The meeting was called to order at 7 PM by Anna Dale. The Pledge of Allegiance was recited.

Due to the large attendance (63 individuals) roundtable introductions were suspended for this meeting. Anna welcomed everyone and moved to presentation.

Presentation

Nate Silcox, Chair of the Public Safety Committee welcomed everyone to Hampden Township. Silcox reiterated the criticality of the volunteer fire service in PA. Less than 38,000 volunteer firefighters currently in PA. COG been looking at the issue for some time; a Firefighters Summit was held in 2016 and it resulted in many thoughts and ideas. The Public Safety Committee has been continuing discussions since that time. Focus is on some of the "low hanging fruit" and things we can do now.

Introduced Jerry Ozog, Executive Director of PA Fire and Emergency Services Institute. Ozog presented "The Future of Volunteer Fire Service - A Time for Transformation." Highlights from the presentation are provided below. A copy of the presentation was provided to all Delegates and Alternates with the February 2018 Board package.

- There is a crisis in many parts of PA.
- Ozog reviewed what has changed and discussed the extreme importance of elected officials and municipal staff to solve problems together.
- Tonight we are setting the stage. Focus is on fire departments tonight.
- Volunteer fire departments (VFD) are typically membership-driven organizations. As a result, decision-making can take a long time.
 - o The self-governance can cause conflict between fire departments and municipalities.
 - Need to understand the culture of the VFD and help them to move toward new ways of doing things administratively and operationally.
- Issues
 - o Consistent staffing 24/7/365 (lack of prime ff age 18 to mid 40's)
 - Lack of next generation succession planning; need to be open and inviting to new members
 - o Live-in programs may have run their course
 - A few successful programs in Central PA but over last 20 years is number of livein programs has declined significantly.
- Many FD operating the same way for the last 30 years. Apparatus and stations are new, but methods aren't.
- Data 36,000 today compared to 300,000 in 1970's. Call volume has increased due to positive economic development.
 - Many reasons people don't volunteer aging PA population, families busier, people working multiple jobs, etc.
- A lot of departments are not fully funded by municipalities, so they have to fundraise.
- Discussed challenges retaining members.
- The solutions are at the local level VFD need mentorship and leadership as well as administrative help.
- Recommended standard is 18 to 22 firefighters on site within a certain period of time.
- Zero standards when a truck shows up as to who is on the truck for the fire.
- Cost of operations for a new firefighter training costs between \$750 \$1000; gear \$7000
- Capital equipment engine \$650,000; aerial/ladder truck 1.4 mil
- If we don't do something now, in five years it will be much worse.
- Many steps to a career fire fighting system don't have to go from volunteer to career. There are things you can be doing to help now.
- Need a commitment to work together elected officials and VFD.

Ozog then introduced Gary Myers, Executive Director of CapCOG. Gary shared that one of the responsibilities of COG is to help our 42 members be aware of situations and make things better. Members work with COG voluntarily - e.g., salt, Comcast, etc. One of first things that came up was to create a retention and recruitment program that our members can use. All have a desire to serve your constituents (elected officials and VFD). We want to find the common ground to help VFD and municipalities.

Opened floor for discussion

Kraig Nace - Duncannon EMS SR6 Commission member.

- The challenge is that our boards, commissions, throughout commonwealth, the same people are doing multiple jobs, multiple volunteer organizations. More critical with VFD - older individuals serving.
- Fire and EMS have similar problems but different requirements. EMS licensed; FD none required. All insurance driven for FD, not government driven.
- Nace believes EMS is over regulated, and FD under regulated.
- Up to municipality to create standard of cover (what type of firefighting do you need? Rural water supply? High rise fire fighting). Depends on the geography.
- Without dialogue and understanding of needs people and money we can't move forward.

Bob Timko - Fairview Township F.D.

 We have pushed the can down the road for decades. We have to make a decision and do something. National Volunteer Fire Council (he serves on). In Germany, they start recruiting volunteer firefighters at age 6. Equipment isn't the problem.

Kasha Griva - Lemoyne Borough

• What was National Volunteer Fire Council? I agree with going into the schools once a month and spending time with kids at a young age would be a good thing.

Margie Stuski - Wormleysburg Borough

- We need to ban two words from legislature unfunded mandate. We need to figure out what we need to do to get where we need to be. It all requires money.
- After 20 years of ignoring problem, it is way beyond that. If legislature is going to keep requiring spending, where does it come from?
- We've added risk with no way to address the risk. Where do municipalities get money to do what they are required to do?

George Drees - Susquehanna Twp Fire Chief

- Volunteer fire station saves \$1m a year.
- VFD should be applying for grants. Call successful grantees and ask to see the grant and use it as a starting point to submit for your own grants. If denied, ask why so you can learn and make adjustments for the next grant. Share your successful grants with others.
- As fire person, we want to show our elected officials that we are doing our part. Susquehanna Township asked to go in 2x a month to elementary school; hang out at recess with kids and be a mentor. Just hang out and play. Still hasn't been allowed.
- Some rural areas do an excellent job recruiting and raising money.

Timko

• For elected officials, if you don't get the grant, the government will come out and talk with you on how to improve on the grant application for the future.

Tom Vernau - Lower Allen Township.

- Regional concept deployment of resources. Where's that stand?
- Ozog responded. There are some very successful regional processes across the state. Has to be
 a willingness to give something up. Younger generations leading our departments they are
 open to seeing something different. Ozog has seen fire departments who wanted to go
 regional, but elected officials didn't want to or vice versa. The goal is to have 24/7/365 coverage
 there are a variety of ways to get there.

Ronnie Allen, Monaghan Township Supervisor

- What can we do so that we don't lose volunteer fire companies? We need to get out there to recruit and make public aware.
- Ozog Altoona and Westmoreland County have recruitment programs. They hired someone full time through a grant to manage the recruitment program. Washington Co. MD, hired a marketing expert to be their recruitment person - she does public outreach for the volunteer fire departments.

Gary Myers - CapCOG Executive Director

- Can COG create a recruitment/retention program for all our members? Could we apply for a grant to make it happen?
- We have to think outside the box. Work with neighboring municipalities; West Shore works.
 Paxtang and Swatara have a police service program that is working across municipal borders providing better coverage for less money.

Christine Zubek, Swatara Township

- One of the important things I've noticed is Jr. firefighter programs and recruitment programs dissipated in a lot of companies. We need to get back to the formalized recruitment and Jr. firefighter programs.
- Jerry Ozog The challenge is that someone has to be in charge of the junior FF program and that can be difficult.

Justin Eberly, Monroe Township, Dept Emergency Management and volunteer FF.

- He is going to VFIS insurance company to represent emergency services as a new career.
- One piece missing is mentorship and formal process; some type of structure. Volunteer system has to have someone to lead every initiative.
- Mentor to develop youth who follows a curriculum of sorts. Exploring -segment of boy scouts -Law Enforcement and Fire Fighter Exploring program. Trying to reinvigorate it in Central PA. Provides resources and regionalized opportunities. Working on putting together a program explaining the program.

Robin Lindsey, Lower Paxton Township

• Three FD in Township; two have live in. Take advantage of EIT and Tax Credit and length of service program (age 65 they get \$250/month for rest of their lives). Currently have 11-12 on the LOSAP program. Really helped in their township.

Timko

• LoSAP - Are SR6 looking at relief association? It was talked about.

Ken Martin, Upper Allen Township

- How do you react to citizens/public officials when mutual aid seems imbalanced?
- Ozog It is about education. What is the recommended amount (18-22) share that recommendation and the reality that the municipality alone can't meet that. It is a challenge.

Frank Wirth, Lower Allen Township Fire Captain

• That imbalance is getting worse. It's a real concern. We are at the precipice now. It can't be kicked down the road any longer.

Drees - The RR Grant opens Friday, February 22 and closes 3/22 - George Drees.

Gloria Zimmerman, West Hanover Township Supervisor

• We have a liaison from the Board of Supervisors who attends all Fire Department executive meetings. We try to support them. They go to summer programs, go around in Halloween and Christmas, visit schools, etc. Transparency is key.

Don Steinmyer, West Hanover Twp Supervisor

• Big problem with volunteer FD - you lose to big cities. When city of Harrisburg is paying firefighters plus offering benefits, or they go to larger municipalities with better benefits, etc.

Ozog

- Surveys done across PA, young people want incentives, cash, etc. Highly incentivized programs are what some are doing (e.g., if you meet certain requirements, get a check at the end of the year).
- State College when you finish their program you get \$5000 stipend. This can take the place of someone having to get a second job to support their family which opens them up to volunteer.

Silcox thanked everyone for coming and Ozog for leading discussion.
