

## 2022 ASSOCIATE MEMBERSHIP

<u>Associate Members</u> are government non-municipal entities such as school districts, other COGs, counties, or organization who support or service municipal government, etc.

**Benefits**: Participation in programs offered by the CapCOG. Participation in **one** program is included with the \$200 annual dues. You may also post job openings on our website as part of your annual dues. Now or at any time during the year you can also choose to participate in other programs for a fee of \$50 per program.

## **PROGRAMS:**

- <u>Joint Bids</u> Note: <u>Each category is a separate program</u> CapCOG compiles quantities to be bid from the participants for projects and materials; create vendor bid packages; advertise; open and review bids; tabulate results; notify vendor of award; and, send bid results with contact information to members. Joint bid contract period is April 1 March 31.
- <u>Salt/Deicer Bids</u> CapCOG compiles quantities to be bid from the participants for salt/deicer; creates vendor bid packages; advertises; opens and reviews bids; tabulates results; notifies vendor of award; and sends results with contact information to participants. Salt contract period is October 1 September 31.
- <u>Surplus Equipment Auction</u> Held in July. CapCOG compiles list of equipment/vehicles from participants, contracts with auctioneer, advertises and conducts the auction. Each participant receives 80% of their sold items/90% for vehicles and heavy equipment.
- <u>Drug and Alcohol Testing -</u> Pre-employment & random selection drug & alcohol testing for CDL and Non CDL . WorkNET is provider.
