## CapCOG Associate Membership

**Associate Members** are designated as quasi-governmental and non-municipal entities such as school districts, other COGs, counties, associations, organizations, etc.

**Annual Dues** - \$200

**Benefits:** Participation in programs offered by the CapCOG. Participation in **one** program is included with the annual dues. **Now or at any time during the year you may choose to participate in other programs for a fee of \$50 per program.**

### PROGRAMS:

- **Joint Bids** – **Note: Each category is a separate program** CapCOG compiles quantities to be bid from the participants for projects and materials; create vendor bid packages; advertise; open and review bids; tabulate results; notify vendor of award; and, send bid copies and results with contact information to participants.
- **Salt/Deicer Bid** - CapCOG compiles quantities to be bid from the participants for salt/deicer; creates vendor bid packages; advertises; opens and reviews bids; tabulates results; notifies vendor of award; and, sends results with contact information to participating members.
- **Surplus Equipment Auction** – CapCOG compiles list of equipment/vehicles from the participants, contract with an auctioneer, advertise and conduct the auction. Each participant receives 80% of the proceeds of their sold items.
- **Drug and Alcohol Testing** - Pre-employment and random selection drug and alcohol testing for DOT and NonDOT. WorkNET is the provider
- **Free or reduced fees for CapCOG Training**, topics include stormwater issues, human resources, etc.
